1. Revised Electronic Submission Protocol

Section 00 21 00, Information to Tenderers, subsection 1.1 of the Uniacke Business Park Expansion - Phase 2 Tender states:

“TENDER SUBMISSION

- .1 Tenders will be received up to 3:00:00 p.m. local Nova Scotia time on October 5, 2021 by electronic submission only, in accordance with the Electronic Submission Protocol on the East Hants website.

Please put the competition number in the subject line of the email: “RFC50399”.

Email tender submissions in before the deadline. East Hants will be sole authority on whether a bid is received on time.”

Please note that the [Electronic Submission Protocol](#) has changed since the Tender was originally published and that responses are to be uploaded through the online procurement application as stated in the current Protocol.

This subsection is therefore revised to read:

“TENDER SUBMISSION

- .1 Tenders will be received up to 3:00:00 p.m. local Nova Scotia time on October 5, 2021 by electronic submission only, in accordance with the Electronic Submission Protocol on the East Hants website.”

Subsection 15, Amendment or Withdrawal of Tender, is revised as follows:

“15. AMENDMENT OR WITHDRAWAL OF TENDER

- .1 New or replacement Tenders must be submitted before the Tender Submission Deadline.
- .2 Once a Tender has been submitted, it cannot be modified. The Tenderer must submit a replacement Tender and then (or concurrently) contact the Procurement Officer to withdraw the Tender which is no longer valid.
- .3 Tenders can only be withdrawn by contacting the Procurement Officer. In order to verify that the person contacting East Hants is authorized to withdraw the Tender, the Tenderer must provide the unique identifying number they received when the Tender was uploaded.
- .4 The request to withdraw a Tender must occur prior to the Tender Submission Deadline to avoid any Contract A obligations which may arise.”
