East Hants Municipal Council has a progressive Municipal Tax Assistance Program. The program provides property tax assistance to households in East Hants who may be struggling to pay their property tax. Qualified applicants will receive a credit, applied directly to the tax account, a minimum of \$216 or up to 20% of their annual tax bill, whichever is the greater amount (based on a Council approved formula).

**TO QUALIFY:**

- You must own (or have a deeded life interest) AND live in the home.
  - Note: Only one property per household will receive the tax assistance.**
- Your total household taxable income, line 260 of all your 2016 Notice of Assessments from Canada Revenue Agency (CRA) was less than the amount indicated in Table A.



**TO APPLY:**

- Complete the application form (on reverse).
- Attach copies of the following documents (which will be received from the Canada Revenue Agency after you file your 2016 income tax):
  - 2016 CRA Notice of Assessment for each adult residing in the home (see sample below).
  - 2016 CRA Notice of Child Tax Benefit (as proof of any dependent children - received in July).

**Note: If you have not yet received this Notice do not delay your application; you may send us your Notice of Child Tax Benefit after you submit your application for this program.**
