My apologies for not responding to you sooner. Between operating my own business and volunteer aspects of the Senior Safety Program Association - it has been to say the least an extremely busy time.

The Board of Directors has met numerous times and worked in between those meetings with the task of saving the Senior Safety Program of Hants County. As was alluded to the Council, after much deliberation, with no signs of assistance, the Board had moved to dissolve and thus end the program at the end of May, 2023. In a light of hope with other funders, we then came back to council with the request to present in hopes of saving this much needed program. *After a lot of thought, the Board of Directors has decided to not put more volunteer hours in preparing and attending another meeting with realistic no sense of hope to change the funding decision made.*

Therefore, the Senior Safety Program for Hants County, will cease to operate in the Municipality of East Hants at this time. Should some circumstances change, this would then be reviewed.

On a personal note, as a Resident of East Hants, a former Manager in Health Care, a former volunteer with the Community Health Board, and one of the people the worked tirelessly to bring this program across the entire County of Hants (moving out of serving the Western sector only) over 10 years ago, to remaining on the Board of Directors through many trying times, including COVID - I am extremely disappointed in the outcomes & thus the route that this dedicated board's members, have put into this essential program and service to the ever increasing senior population, has had no choice but to make.
