Summary

The 'General Government Grants Policy' is being reviewed as part of Council's Policy Review Program. The draft version of the Policy contains minor language changes, adds reference to the Municipality's 'Strategic Plan', and simplifies the application deadline.

Background

The 'General Government Grants Policy' (the 'Policy') outlines four (4) different types of Municipal grants along with their eligibility and application requirements. These four (4) grants are:

- Use of Municipally owned facilities;
- School bursaries;
- Grants to community organizations; and
- Grants to non-profit organizations.

These grants are intended to support the development of a strong Municipal community. When financial assistance is given, these grants generally do not exceed \$2,000. This grant distributed to both annual recipients and select organizations that apply to Council as needs arise. Examples of previous recipients of the General Government Grant include:

- Aquatic Centre rental for East Hants Schools' Safe Grad;
- Food bank and Christmas programs support;
- Remembering Canada's Heroes;
- Hants County Exhibition.

This Policy is being reviewed as part of Council's Policy Review Program. To complete this review, meetings were held with the following individuals or groups:

- The Senior Grant Review Committee;
- The Chief Administrative Officer; and
- The Community Development Coordinator.

Discussion

There are no major updates associated with this Policy review. The proposed changes represent minor language updates and clarifications.

One proposed change includes adding reference to groups, programs, or services that align with the Municipality's 'Strategic Plan' in Sections 1.1.4 and 3.1.5. This change gives provides greater clarity on groups that are eligible to receive funding under this grant program.

The second proposed change is a simplification of Section 4.1, which states all applications will be received on a first-come, first-served basis. This proposed change simplifies the Policy for groups seeking funding, while providing clarity to Municipal staff on the administration of grant applications.

STRATEGIC ALIGNMENT

The draft Policy aligns with the Municipal Key Strategies of Corporate Excellence and Strong Communities.
