## Recommendation

That the Corporate & Residential Services Committee provides direction to staff/Council to include a statement representing African Nova Scotian Heritage.

## **Suggested Motion**

If you choose to do this, we recommend the following wording:

Move that the Corporate & Residential Services Committee recommends Council approve the following wording for the Land Acknowledgement as required under the Council Procedural Policy to be as follows:

"I would like to begin by acknowledging that we are in Mi'kma'ki and the District of Sipekne'katik, the ancestral and unceded territory of the Mi'kmaq people. East Hants further acknowledges the 50 African Nova Scotian communities whose 400-year history have contributed to the provinces culture, history and legacies. We are all Treaty people."

## Background

The Municipality of East Hants reads an Indigenous Land Acknowledgement at Executive Committee meetings, other Committees of Council, Regular Meetings of Council and all major public events. The decision to include a land acknowledgement at Council meetings was made in 2018 and expanded to the Executive Committee and other Committees of Council and events in 2022.
