1) Overall, NSPHA realized NOL results that was within budget. Category highlights are as follows:

Revenue - The rent cap was expected to be lifted in February 2022 but did not occur until June 2022.

Utilities - significant increase in the average price of fuel oil

Infrastructure - construction jobs were impacted by inflationary pressures, supply chain, and additional funding.

Other NOL Categories - NSPHA adjusted plans to mitigate other budget pressures.
