Fall 2023 Update

Going Ons

Fall is a busy time of year for PVSC. Assessment staff are attending appeal hearings, conducting analysis and review for the 2024 reassessment, and are in the field performing permit inspections.

In addition to these activities, PVSC is also monitoring remediation and rebuild efforts in Halifax, Shelburne, and Barrington after the wildfires this summer, as well as capturing structural damage and/or environmental contamination after the July floods and Hurricane Lee.

We are asking that property owners call us if their property has sustained structural damage or environmental contamination so we can email them a questionnaire to collect more information.

A bulletin with instructions for property owners is attached, which you can share with property owners, post on your website, or share in upcoming newsletters, etc.

Monitoring the Market

PVSC continues to use several advanced modeling tools to conduct in-depth market analysis and support data-driven decision-making.

With a shift in Nova Scotia's real estate market beginning in early 2020, tracking and evaluating market trends is foundational to producing a fair and accurate assessment roll. Our data science and operations staff work closely to understand the sales and trends for different sectors and property types across the province.

Permits

Important: By ensuring permits are up-to-date in PDX you help us to prioritize permit reviews.

As building permit inspections are ongoing, it is vital that **all permits are received in a timely manner and under the correct inspection status**. A reminder that when assessment staff are in the field, they have PVSC-issued identification, wear high-visibility vests, and their cars are marked with PVSC decals.
