East Hants vs West Hants Property Tax Rates:

Trying to compare and truly understand different municipal property tax rates can be very challenging. There are a variety of reasons for this including:

- There is no standard methodology for charging property taxes.
- There are a number of service fees that can be grouped together, or charged separately.
- Terminology can differ between municipalities.
- Published documentation as to what is included can be difficult to understand, or lacking in detail to enable a true understanding.

If you are able to get to a true apple to apples comparison, there are going to be many very valid reasons why the tax rates vary.

Trying to compare and truly understand the differences between the East Hants and West Hants property tax rates is no exception to this. The information below will however provide some useful insight. But it does not provide complete insight.

West Hants has a relatively simple property tax rate structure compared to East Hants. It has three geographical regions, each with a Residential/Resource rate and a Commercial rate. Fire and waste collection are already built into these rates. The 2024/2025 rates are noted below.

West Hants

Residential/Resource General <mark>\$0.9723</mark> (General Rate \$0.6972 + Area Rate \$0.2751) Commercial <mark>\$1.78</mark> (General Rate \$0.9800 + Area Rate \$0.8000)

Hantsport

Residential/Resource General \$1.3537 (General Rate \$0.6972 + Area Rate \$0.6565) Commercial \$3.75 (General Rate \$0.9800 + Area Rate \$2.7700)

Windsor

Residential/Resource General \$1.6464 (General Rate \$0.6972 + Area Rate \$.9491) Commercial \$3.85 (General Rate \$0.9800 + Area Rate \$2.8700)

East Hants

The East Hants 2024/2025 all-inclusive tax rates (Residential/ Resource and Commercial) as listed in pages 20 to 23 of the Operating Budget document are listed on the following four pages. It must be noted however that in addition to these rates, the municipality charges a waste management fee of \$220 per dwelling unit.
