Chris,

In response to the attached letter I offer the following:

The province is looking at realigning the intersections of Hwy 277 and Logan Drive in the future. When that happens would be the time to look into potential active transportation connectivity. We believe provincial coordination cross departmentally between Education and NSDPW would be the best path forward for working that into a master plan. Measuring the distance from the traffic circle to Church St. being about 165m, the question is whether a Church Street crossing would be too close. If a crossing were to be approved by NSDPW, where would it need to go and what would the technical criteria be for NSDPW to approve.

If Education and NSDPW can work collaboratively to see what is possible with respect to Provincial regulations and planning, then bringing in the Municipality at that time with respect to capital planning would be the next step in a path forward. And of course, any proposed capital project would then need to go in front of Council for approval. Council has generally made evidence based decision where a demonstrated need has been established.

Lets keep the dialogue open and loop NSDPW in as the realignment at the 277 makes its way up their priority list.
