Dear Members of Council.

We are writing to express our full support for Shore Girl Adventures, a new tourism business being launched by Denise Thompson, a long time resident of East Hants and a dedicated contributor to our community.

Denise is a valued and proactive member of our region, organizing numerous community events and initiatives that bring residents together and celebrate our shared connection to this extraordinary coastline. Her newest venture, Shore Girl Adventures, is a natural extension of this commitment—offering ocean floor tours, as well as historical and educational experiences that our shoreline urgently needs.

Being involved in local tourism and hospitality, we can speak firsthand to the challenges our area faces. While Burntcoat Head Park is a world-renowned destination, its current tour schedule and staffing limitations mean that many visitors leave without the chance to explore the ocean floor with a local interpreter—one of the primary reasons they come here. Between June 15th, 2025 and October 15th, 2025, there are 122 days in total. Tours are scheduled on 64 of those dates, while 58 dates currently have none. That's about 47% of days with no tours planned or scheduled. Across the 64 tour days, a total of 72 tours are scheduled. Of those, 16% are already sold out, and another 11% have only one spot left—highlighting strong interest and limited remaining availability. This season alone, we've had multiple guests disappointed when no guided tours were available during their stay, often due to tide schedules not aligning with park hours or tours being sold out due to limited group sizes.

There is a clear and growing demand for meaningful outdoor experiences along the Fundy coast, especially at Burntcoat Head Park, and Shore Girl Adventures is poised to meet that need. Denise's tours will be locally led, educational, and responsive to tide timing—offering flexible and consistent options that complement the existing offerings at Burntcoat Head Park, rather than compete with them.

In addition, Shore Girl Adventures strongly aligns with the Municipality of East Hants Strategic Plan, particularly the goals of:

East Hants Tourism Strategy 2019 -

"Supporting development of niche tourism experiences which align with East Hants assets and target EQ segments (e.g.: agritourism, fishing/naturalists, artisans)."

To advance the growth of the tourism industry by creating and sustaining an environment which provides a rewarding experience for visitors and citizens of East Hants and celebrates our natural and built attractions and assets."
