
Gentlemen:

Under our License No. 13670 dated December 24, 1921, Messrs. J. A. Kirkpatrick, Watson Smith, and Robert Gass, were placed under lease for 1,500 square feet of land at Shubenacadie for a war memorial site at a rent of \$1.00 per annum.

We have recently been advised that both Messrs. Gass and Smith are deceased and that your branch of Legion has taken over the rental and maintenance of the monument. As it would be desirable to have the agreement formally transferred to your organization, you should (if you have no objection) arrange to obtain the duplicate original of License No. 13670 from Mr. Kirkpatrick and forward same to this office.

As soon as assignment of this license has been prepared, it will be returned to you.

Dear Mr. Kirkpatrick:

We understand you are presently the sole holder of our Agreement No. 13670 which covers a lease of 1,500 square feet of land near Shubenacadie Station for use as a war memorial site, but that you have in fact given over most or all of the responsibility for the property covered by the Agreement to the Canadian Legion, Shubenacadie Branch #111.

We have had some correspondence with Mr. W. F. Wyer, Secretary of Branch #111, and the Legion has confirmed its willingness to pay the rental and perform the necessary maintenance on the memorial and grounds in future. However, Mr. Wyer has suggested that we contact you to obtain the duplicate original of the Agreement, which under the circumstances would have to be assigned to the Legion.

If you can locate your copy of Agreement #13670, please send it to this office. If not, please advise and we will have a new agreement prepared in favour of the Canadian Legion, Shubenacadie Branch #111, and will have yours cancelled.
