HOUSING STRATEGY - FINAL REPORT

PAC25(117) On the motion of Councillors Merriam and Dixon:
October

Moved that the tabled motion PAC25(86) be lifted from the table (for further discussion).

The Committee unanimously agreed.

For clarification, Motion PAC25(86) is as follows:

That the Planning Advisory Committee recommends to Council that Council approves the East Hants Housing Strategy, striking the item regarding five (5) mini-homes in the RU Zone from the Strategy.

The Director of Planning & Development and Planning Team presented a report and presentation titled “East Hants *Housing Strategy*” dated July 3, 2025. The report was attached to the agenda and available to all committee members.
