**Important Notes:** This ticket CANNOT be paid at a police station.  
Always include your original ticket with your payment.

**Late Payments:** After 60 days, additional fees will be added to your ticket amount. After the court date on the summons, payments must be made directly to the Provincial Court.

**Disputing the Ticket:** To plead not guilty, do not make a payment. You will receive a Summons in the mail after 30-days of non-payment with the date, time, and location of your court appearance. At your first court appearance, you will enter a plea, and a trial date will be set. On your trial date you will be required to attend court.
